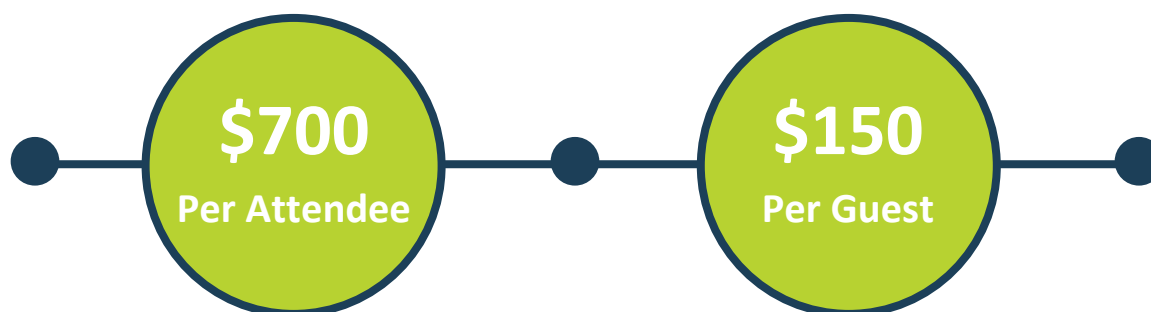

- Log in and edit breakout session selections until May 4, 2018

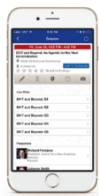
REGISTRATION FEES

Please make your reservations as soon as possible. Rooms in the block are expected to fill up well before the cut-off date. Please be aware that those attendees unable to reserve rooms at The Renaissance Chicago Downtown will need to secure lodging and transportation to the meeting on their own.

TRANSPORTATION

Attendees are responsible for their transportation to and from the meeting. Transportation includes booking airline tickets and any shuttle service, rental car, Uber rides or taxis.

Chicago O'Hare (ORD) airport is located 18 miles from The Renaissance Downtown Chicago. Major airlines at ORD include Air Canada, American, Delta, Jet Blue, and United. Taxi fare is approximately \$45 one-way from ORD to the hotel.

Chicago Midway (MDW) airport is located 12.1 miles from The Renaissance Downtown Chicago. Major airlines at MDW include Delta, Frontier, Porter, and Southwest. Taxi fare is approximately \$30 one-way from MDW to the hotel.

Both airports have rental cars available from all the major carriers. However, reservations are recommended. Upon arrival at the hotel, public transportation is readily available to travel throughout the downtown area. Valet parking at the hotel is an additional \$69 per day plus tax (subject to change). Please note that the hotel cannot accommodate oversized vehicles.

Airport Transportation Option: Go Airport Express charges \$35 one way from O'Hare and \$30 one way from Midway (prices subject to change). Advanced booking is required. Visit: www.goairportshuttle.com.

Breakout #1 - Top FAQs from TAI Users & Basic System Training

Inspired by the launch of [TAI's FAQ Blog Series](#), this session will answer the most frequently asked system questions from our users. We will touch on topics such as the basic setup of key reinsurance tables on the TAI .NET and Mainframe platforms; and outline the different ways to process reinsurance and claims. We will also consider the impact of updates and their downstream effect on the different screens within the TAI application. In addition, attendees will have the opportunity to ask about specific challenges they face within the system. The session is open to all system users.

Breakout #2 - How to Process Annuity Reinsurance with Ease on TAI

Discover how to use TAI Annuity, the platform designed to help clients process annuity business with ease. This session will deliver an overview of basic system processing and tools, plus demonstrate how the processing differs from that of life and health reinsurance. We will then take a more in-depth look at how annuity products flow through TAI and answer key questions including:

- How the reinsurance arrangement works
- How annuity-specific additional expense allowances, acquisition fees, commissions, etc. are handled
- How the transaction-based policy master extracts differ from a point-in-time policy snapshot
- How TAI handles roll-forward tracking

Breakout #3 - How Does TAI Protect Your Data? Plus the Must Know Data Security Trends for Insurance Professionals

The ever-changing world of information security requires professionals who work with data to stay on top of the latest trends, threats, and best practices that impact their day-to-day responsibilities. It is equally important to understand the data security protocols in place to protect the data that comprises the lifeblood of your reinsurance business.

Join this session to understand how TAI enforces data security to protect clients' data. Review the investigation and notification standards for cybersecurity events proposed by the NAIC's adoption of the Insurance Data Security Model Law. Then, discuss the latest security trends in the life insurance industry to help you start preparing for the future of data security.

Breakout #4 - Leveraging Artificial Intelligence and Machine Learning to Test the Accuracy of Treaty Data in TAI

The treaty is the single source of truth within the world of reinsurance. But how confident are you in the accuracy of the treaty data in your TAI system when stacked against the paper treaty? And more importantly, how easy is it for you to review your data and test for accuracy?

Conducting a thorough treaty review can reveal much about the health of reinsurance administration practices. However, it requires a substantial amount of time and resources, both of which are limited in our industry. Join us as we reveal best practices for conducting treaty reviews: what errors, exceptions and financial impact reviews can expose; and how artificial intelligence and machine learning can make this process more efficient.
